Privacy Policy for online customers and website or online media users

The company is aware of the importance and duties under Personal Data Protection Act B.E. 2562, therefore, the company has established a personal data protection policy This edition applies to the personal information of online customers. Website users and online media to inform the following details How does the company collect your personal information? What information is collected by the company for what purpose is it processed? How your information is disclosed, what measures are in place to protect your information, including your legal rights as a personal data subject.

1. Policy Coverage

This policy covers the personal information of online customers and users of the website and other related to online customers and users of the company website.

2. The meaning of Personal data

2.1 Personal data means information about an individual that enables an identifiable person, either directly or indirectly. but does not include information of the deceased in particular

2.2 Sensitive personal data means that personal data relates to race political opinion cult religion or philosophy sexual behavior Criminal records, health information, disability, trade union information Genetic data, biological data, or any other information which affects the owner of personal data in a similar manner as specified in the notification of the Personal Data Protection Committee.

3. What personal information is collected?

We will collect personal data which is information that makes you personally identifiable. Whether directly or indirectly, this includes information you provide directly from registration through the KIOSK Member system, registration for company activities, cookies, transaction data. and user experience through the website assigned person or any other channels such as.

- 1. Personal information such as name, surname, age, identification number passport number
- 2. Contact information such as residence, place of work, telephone number, e-mail address, line
- 3. Device or tool information such as IP Address MAC Address Cookie ID
- 4. Other information such as website usage, sound, still image, animation and any other information that is considered personal information under the Personal Data Protection Law.

4. Purpose for collecting, using or disclosing personal data

We will use your information for the development and improvement of the website https://www.kioskthailand.com online platform and other affiliated social media channels, as well as analyzing and processing personal data. to meet the needs of users electronic methods for you to be more efficient If there is a change in purpose later The company will inform you to ask for consent and provide a record of the amendments as evidence

The company will not collect, use or disclose your personal information. for other benefits other than the purpose that was notified to you before or at the time of collection

5. Disclosure of your personal information to third parties

The Company will ensure that employees specifically assigned in this regard do not use or disclose, display or otherwise appear in your personal data. in addition to the purpose to the extent permitted by law to disclose to the extent you have given your consent. or the scope involved in this policy

In the event that the Company will disclose your personal information to a third party or juristic person The third party or juristic person must first inform the Company of the purpose of using or disclosing your personal information to the Company. and must not use or disclose personal information In addition to the objectives that have been given to the Company

The Company may disclose your personal information to the analytics partner companies. for analysis and development of products and/or services conducting research or producing statistical data business administration and marketing promotions, such as publicizing events, products and/or services to you

In the event that the Company uses or discloses personal information that is exempt from obtaining consent The Company shall record the use or disclosure of such information in writing or electronically. The Company may disclose personal information outside the law. In such cases, the Company may be required to disclose your information in order to comply with applicable law or regulatory requirements. This includes complying with orders of law enforcement agencies, court officials, government agencies, or other third parties. In the event that the company believes it is necessary Must comply with legal duties or to protect the rights of the company rights of persons or for the safety of persons or to investigate, prevent or deal with fraud or security matters.

6. Sending your personal information abroad

The Company may disclose or transmit your personal information to third parties or servers located in foreign countries where the destination country may not have an equal level of protection. Ensuring that data transmission is safe and that the recipient destination is protected appropriate information However, the company will expressly request consent from the owner of the personal data on the transmission or transfer of the information to foreign countries such as the company's branch in Myanmar.

7. Period of collection of personal information

The Company will collect your information with your consent. Except in the case where the law gives power under the Personal Data Protection Act B.E. 2562, Section 24 or Section 26

The company will collect your information for a period of 10 years.

The Company will collect your information only as necessary. under the objectives stated by the Company in Article 4.

However, if it is necessary for you to provide personal information to the Company in order to comply with the law. The company will inform you in advance. and will notify the impact if you do not consent to the information to the company

The Company will not collect your information from sources other than you directly. Unless the Company has notified you of the collection of your information from other sources within 30 days and has obtained your consent. or is a collection that is exempt from requiring consent According to the Personal Data Protection Act B.E. 2562, Section 24 or Section 26

The Company will not collect personal information related to race, ethnicity, political opinions. cult religion or philosophy sexual behavior Criminal records, health information, disability, trade union information Genetic information, biological information or any other information that affects you in a similar manner pursuant to the notice of Personal Data Protection Committee without your express consent except in the case of the Personal Data Protection Act, B.E. 2562, Section 26

8. Security of personal information

The Company will keep your personal information very well in accordance with the Technical Measures and administrative measures. (Organizational Measures) to maintain appropriate security and security in the processing of personal data. and to prevent personal data breach, loss, unauthorized access destroy, use, transform, modify, use or disclose information outside the intended purpose or without power or without Before the company collects, uses or discloses your information The company will ask for your consent first. By obtaining consent, the Company will do so expressly. in a book or made by an electronic system You are free to give your consent to the company collecting, using or disclosing your personal information. The Company does not stipulate conditions for giving consent to access the service. or enter into a contract with the company If the personal data is not necessary or relevant for entering into a contract or receiving the service.

In addition, executives, employees, employees, contractors, agents, consultants and recipients of information from the Company are obliged to maintain personal information in accordance with the confidentiality measures established by the Company.

In the event that the owner of the personal data is under the age of majority considered a minor under the Civil and Commercial Code Your consent requires the consent of the parent having the power to act on your behalf. If the person giving consent is a minor under 10 years of age, consent must be obtained from the person exercising parental power directly.

In the event that any owner of personal data is an incompetent person or a quasiincompetent person Consent must be obtained from the curator or guardian who has the power to act on behalf of the incompetent or quasi-incompetent person, as the case may be.

The Company will ensure that your information is accurate, current, complete and does not cause misunderstandings.

9. Ownership rights of personal data

- Access to personal data: Personal data subjects can request access to personal data and request a copy of your personal data that the company has collected, used or disclosed. The company may ask you to prove your identity. Accessing such personal data is for the security and privacy of the data subject.
- 2. **Right to withdraw consent:** Personal data subject has the right to revoke the consent given to the Company for the collection, collection, use or disclosure of such personal data. at any time during the time your personal information is with the company Unless there is a limitation on that right by law or contract that bestows benefits on the subject

of personal data. However, the revocation of consent may affect the data subject. Please inquire and study the impact before withdrawing such consent.

- 3. **Right to correct personal data:** The owner of the personal data has the right to request that the Company Edit your personal information that the company has collected, used or disclosed to be accurate, complete and current
- 4. **Right to transfer personal data:** Owners of personal data have rights. of receiving personal information about you that the Company has and has made such information in a readable or usable form in electronic form; and To transfer such information to another personal data controller, provided that such information must be Personal information that the owner of the personal information has given to the company and obtaining your consent to collect, use and/or disclose or to perform the contract the Company has with the personal data subject
- 5. **Right to object:** The data subject has the right to object to the collection, use or disclosure of your personal data.
- Right to request for suspension of use: The owner of the personal data has the right to request the suspension of the use of the personal data except in some cases. (restrictions on legal rights or the contract between the company and the owner of the personal data)
- 7. **Right to erasure or destruction of data:** You have the right to request that the Company delete or destroy your personal data except where the collection of such personal data is in accordance with the law or in order to establish a legal claim. Refers to the use or defense of legal claims
- 8. **Right to complain:** The owner of the personal data has the right to lodge a complaint with the competent authority. If you believe that the collection, use or disclosure of your personal information is inconsistent with the data privacy laws.

10. How do we use cookies?
